School districts

Funding Sources; Uses and Use Restrictions

Federal funds; In order to meet the varying needs of school districts three types of grants are available: Planning, Implementation, and Institutionalization. The MCSC funds planning grants to school districts that have never received Learn and Serve - Michigan funding to enable them to incorporate service-learning throughout the district. Implementation grants are provided to expand and sustain the practice of quality service-learning throughout the district. Institutionalization grants are provided to enable districts to sustain quality service-learning practice.

Assistance Considerations; Formula and Matching Requirements

The ultimate goal of funding is to assist applicants in establishing sequential service-learning opportunities so that at a minimum all students will have at least one service-learning experience at the elementary, middle, and high school levels.

Eligibility Requirements

Educational institutions (local school districts, intermediate school districts, colleges and universities, etc.), local government entities, state agencies, and nonprofit organizations that have their 501(c)3 status and have been in existence for at least 3 years are eligible to apply for a Michigan's AmeriCorps program.

Funding Sources; Uses and Use Restrictions

Federal funds; Michigan's AmeriCorps grants are not for the purchase of program supplies or materials, nor can they be used to fund or replace existing staff. The Michigan's AmeriCorps funding is intended for recruiting, placing, and supporting volunteers to get things done in communities.

Assistance Considerations; Formula and Matching Requirements

Programs must be large enough to achieve a demonstrable impact on the communities served. While the actual size of each program may vary depending on the size of the communities in which it operates, the design of the program, and other factors, applicants are required to apply for at least ten (10) full-time equivalent AmeriCorps members.

Applicants should evaluate their present infrastructure and capacity when considering program size. Grant requests may vary in size depending on the type and scope of the proposed program. Applicants are allowed flexibility in developing their budgets, within federal and state limitations. No program funded through the MCSC formula allotment shall receive more than 20% of Michigan's total formula funding from the CNCS.

For the 2010-11 application year, we anticipate the maximum will be \$526,000. In addition, the MCSC has set a target of \$12,600 for the average federal cost per full-time equivalent member for each Michigan's AmeriCorps program. Substantial cash and in-kind matches are required from the applicant. All program costs require at least a 24% cash and in-kind match during each of the first 3 years of funding, with match requirements increasing incrementally after year three. Programs reach a maximum 50% minimum match level during the 10th year of funding. Programs may use other non-CNCS federal funds as part of their match, with prior approval.

The Michigan Department of Agriculture's Michigan Turfgrass Environmental Stewardship Program was designed for golf courses to increase regulatory compliance, protect groundwater and surface water quality, enhance wildlife habitat, and publicly recognize golf courses for their environmental accomplishments. The scope of the program includes fuel, pesticide, and fertilizer management; wellhead and surface water protection; and wildlife habitat enhancement. Golf course superintendents participating in the program attend a one-day workshop, complete self assessment materials and participate in an on-site visit to establish a 3-year environmental action plan leading towards certification in the program.

(8.) federal block grant funds may not be used to supplant existing funding or existing mental health services in the State of Michigan. (9.) Also DO NOT include ongoing "space costs" (office space) on your budget unless you indicate clearly that no block grant funds will be used for these space costs. The only space costs that block grant funds can pay for are rental costs for meetings or trainings.

The maximum funding per project is up to \$75,000 for the first and second years with a required local contribution of one dollar for each three Mental Health Block Grant (MHBG) dollars (1:3). The maximum funding per project is \$50,000 for the third, fourth and fifth years, with a local contribution of one dollar for each one MHBG dollar (1:1). At least one-half (½) of the local contribution must be cash from any source that can be used to provide the services proposed. The remainder of the local contribution may be in-kind. The local contribution for block grant funds can come from any source. Some examples include: General Fund, Medicaid, Child Care Fund, United Way, or other local funding.

Eligibility Requirements

To be eligible, a P2 project must reduce waste generated by the facility, reuse or recycle that waste in an environmentally sound way, or reduce water or energy usage.
